# 1 Change Proposal

This Change Proposal contains the following:

• Request for enhancements relating to the automation interfaces for the VicGas Wholesale Gas Market system of VENCorp.

# 1.1 Description of the proposed change

The VicGas Wholesale Gas Market Automation Web Services are implemented by VENCorp, and are split up into a number of discrete services relating to particular areas of functionality:

- Bid service
- Demand forecast service
- Injection hedge nomination service
- Agency injection hedge nomination service.
- System service

The document/literal contents in the VENCorp web services are based upon the existing **aseXML specification** to be updated to include new transactions specifically defined for the new wholesale gas market and detailed in the following sections of this document. The web services XML Schema is a subset of the aseXML specification, and uses elements and types defined within the aseXML schema.

Note, in spite of batching capabilities incorporated into aseXML, the VENCorp web services will carry only a single transaction, and no batching is allowed.

The use of aseXML Header element is not required by web services. The conversation is always held by an authenticated party to VENCorp. In this scenario, the use of header is redundant. However, to ensure consistent ussage, the aseXML header will always have populated all mandatory elements:

Values <From> and <To> elements when generated by VENCorp will be set to "VENCorp WebExchanger" and the MarketParticipant's company name respectively. VENCorp will not be validating the values provided in those fields as the web service call origin context will be already known, and the user/system had been authenticated.

The <MessageID> will be populated with a unique identifier. The <MessageDate> will have the date/time when the message has been generated by the application or the web services client. The <TransactionGroup> will always be set to MKTW. The <Priority> element will always be set to Medium. The <Market> element will be always set to VICGAS.

The proposed changes are listed in the following table.

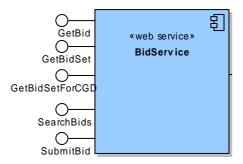

# 1.2 Web Services - Bid Service

The Bid Service is responsible for all bid-related functionality, including retrieving bid information, searching for bid information and submitting new bid information to the VENCorp gas market system. The UML representation of the operations exposed via this web services is shown in the following figure.



# 1.2.1 GetBid

The getBid() method obtains all the data for a particular bid based on its bid identifier in the VENCorp system (Bid ID), including the individual bid steps that comprise the bid stack.

Only bids submitted by the logged in user, or another user within the same company/organization, will be viewable using this method.

# 1.2.2 GetBidSet

The getBidSet() method obtains all the data for a particular bid set based on its bid set identifier in the VENCorp system (Bid Set ID). A bid set is a collection of bids which can span multiple days (a standing bid) or represent a single day's set of bids for one or more scheduling horizons.

# 1.2.3 GetBidSetForCGD

The getBidSetForCGD() method obtains all the data for the latest bid set for the current gas day. This is a convenience method as the same data can be obtained via the related getBid() or searchBids() calls.

# **1.3 SearchBids**

The searchBids() method searches for bid information matching the criteria specified in the request message. The search can be based on:

- Start and end date
- MIRN
- Bid Type (Injection/Withdrawal)

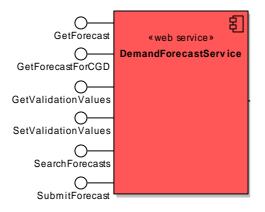
The response message will contain zero or more matching bids.

# 1.4 SubmitBid

The submitBid() method submits bid information for processing by the VENCorp gas market system, using the supplied date range, bid type and price/quantity information. SOAP faults will be generated if the submission is not accepted due to missing the interval cutoff time and for other reasons. The possible SOAP faults are documented below along with the potential causes of the faults.

# 1.5 Web Services – Demand Forecast Service

The Demand Forecast Service is responsible for all demand forecast-related functionality, including retrieving forecast data and submitting new forecast information to the VENCorp gas market system.



The service provides the following operations:

- GetForecast
- GetForecastForCGD
- GetValidationValues
- SetValidationValues
- SearchForecasts
- SubmitForecast

# 1.5.1 GetForecast

The getForecast() method obtains all the data for a particular demand forecast based on its demand forecast identifier in the VENCorp system (Demand Forecast ID), including the individual hourly values that comprise the forecast.

# 1.5.2 GetForecastForCGD

The getForecastForCGD() method obtains all the data for the latest demand forecast for the current gas day. This is a convenience method as the same data can be obtained via the related getForecast() or searchForecasts() calls.

# **1.5.3 GetValidationValues**

The getValidationValues() method retrieves the demand forecast hourly validation values supplied by the participant during the initial VENCorp gas market registration process. These values provide an upper limit on the forecast values that can be entered by the participant for demand forecasts, either through the web front end or via SOAP.

# 1.5.4 SetValidationValues

The setValidationValues() method sets the demand forecast hourly validation values that are initially supplied by the participant during the VENCorp gas market registration process. These values provide an upper limit on the forecast values that can be entered by the participant for demand forecasts, either through the web front end or via SOAP.

### **1.5.5 SearchForecasts**

The searchForecasts() method searches for demand forecast information matching the criteria specified in the request message. The search can be based on:

- Start and end date
- Site specificity
- MIRN (if site specific)

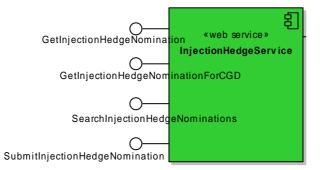
The response message will contain zero or more matching demand forecast records.

#### **1.5.6 SubmitForecast**

The submitForecast() method submits demand forecast information for processing by the VENCorp gas market system, using the supplied date range, MIRN (for site specific forecasts) and other information. SOAP faults will be generated if the submission is not accepted for whatever reason. The possible SOAP faults are documented below along with the potential causes of the faults.

# 1.6 Web Services – Injection Hedge Nomination Service

The Injection Hedge Nomination Service is responsible for all injection hedge nomination functionality, including retrieval of the historical data and submission of new injection hedge nominations to the VENCorp gas market system.



The service provides the following operations:

- GetInjectionHedgeNomination
- GetInjectionHedgeNominationForCGD
- SearchInjectionHedgeNominations
- SubmitInjectionHedgeNomination

# **1.6.1 GetInjectionHedgeNomination**

The getInjectionHedgeNomination() method obtains all the data for a particular injection hedge nomination based on its identifier (Injection Nomination Header Id).

Note, the number of entries returned in AMIQS element of the response will be equal to the number of scheduling intervals in a gas day. If no AMIQ value was supplied during the submission, then zero will be stored.

# 1.6.2 GetInjectionHedgeNominationForCGD

The getInjectionHedgeNominationForCGD() method returns the injection hedge nomination that is effective for the current gas day.

### **1.6.3 SearchInjectionHedgeNominations**

The searchInjectionHedgeNominations() operation is responsible for the retrieval of injection hedge nominations that fall into specified period. This operation will return data if:

- There is a nomination either standing or for individual gas day, and
- The date range provided in the parameter is either completely enclosed in the above standing nomination, or
- Period's termination date is <u>after</u> than the nomination's commencement date, or
- Period's commencement date is <u>before</u> the nomination's termination date.

Only nominations submitted by the logged in user, or another user within the same company/organization, will be viewable using this method.

#### **1.6.4 SubmitInjectionHedgeNomination**

The submitInjectionHedgeNomination() operation submits injection hedge nomination information for processing by the VENCorp gas market system, using the supplied date range, MIRN and other information.

AMDQ and AMDQ Credit quantities supplied in the request must be of integer type, in GJ. AMIQ profile values are percentage. AMIQ profile values must be provided for every scheduling interval.

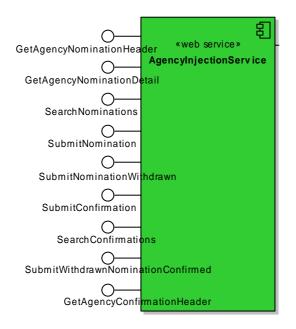
# 1.7 Web Services – Agency Hedge Nomination Service

The Agency Injection Hedge Nomination Service is responsible for all agency-related functionality. That includes all the functions available through the front-end browser interface, i.e. nomination of an agent, confirming nominations, withdrawal of nominations, and search for historical agency nominations.

Please note the usage of AgencyNominationHeaderId and AgencyNominationId:

• AgencyNominationHeaderId is an identifier for the entire group of nominations submitted at the same time. This corresponds to the Agency Nomination screen on the VENCorp gas market system's browser interface where up to 10 agency nominations can be made. The AgencyNominationHeaderId is returned to the user following the successful submission of the group of nominations.

• *AgencyNominationId* is an identifier of the individual agency nomination as it is being tracked by the VENCorp gas market. This identifier appears next to the individual agency nomination following the successful submission. It is the identifier that will be returned/displayed when searching for nominations.



This service provides the following operations:

- GetAgencyNominationHedaer
- GetAgencyNominationDetail
- SearchNominations
- SubmitNomination
- SubmitNominationWithdrawn
- SubmitConfirmation
- SearchConfirmations
- SubmitWithdrawnNominationConfirmed
- GetAgencyConfirmationHeader

# 1.7.1 GetAgencyNominationHeader

The getAgencyNominationHeader() operation is responsible for the retrieval of the set of agency nominations identified by the provided header identifier -AgencyNominationHeaderId.

# 1.7.2 GetAgencyNominationDetail

The getAgencyNominationDetail() operation is responsible for the retrieval of the individual nomination details as specified in the operation parameter.

# **1.7.3 SearchNominations**

The searchNominations() operation is responsible for retrieval of the agency nominations that satisfy the search parameters.

#### ASWG Change Management Process

Version 5.0

The mandatory parameter <NMI> specifies the meter for which the search must be performed. The optional parameter <Period> defines the date range for which the agency nomination will be searched for. If not specifed, then the current gas day will be assumed.

# 1.7.4 SubmitNomination

The submitNomination() operation will allow the user to submit the agency nomination to the VENCorp gas market system. The user will be able to submit nominations for meters registered to the company/organisation the user belongs to.

Upon successful submission, the VENCorp gas market system will generate notification emails (in accordance with the Participant Build Pack to the nominated party, and the company/organisation who created the nomination.

### 1.7.5 SubmitNominationWithdrawn

The submitNominationWithdrawn() operation allows the user to withdraw the previously submitted agency nomination. It does not provide for the withdrawal of the entire nomination group (as identified by the header id), but rather the individual nomination (as identified by the nomination id).

An individual nomination can be withdrawn either before the confirmation for that nomination is submitted, or after the confirmation. In both cases notifications will be generated by VENCorp gas market system to the counterparties.

Upon successful submission, the status of the nomination will be set to "NWDN".

# **1.7.6 SubmitConfirmation**

The submitConfirmation() operation is responsible for submission of a confirmation for the individual agency hedge nomination. This confirmation, upon successful submission, will change the status of the specified agency nomination to "NCON". The successful operation will trigger a notifications sent to both parties.

# 1.7.7 SearchConfirmations

The searchConfirmation() operation is responsible for searching the submitted agency nomination confirmations. The only confirmations submitted by the logged in user, or another user from the same company/organisation will be viewable from this operation.

#### 1.7.8 SubmitWithdrawnNominationConfirmed

The submitWithdrawnNominationConfirmed() operation is responsible for submission of the confirmation for the the nomination that had been withdrawn. Only nominations made to the logged-in user, or another user from the same company/organisation will be updateable via this operation. The successful submission via this operation will change the status of the specified nomination to "WCON".

# 1.7.9 GetAgencyConfirmationHeader

The getAgencyConfirmationHeader() operation is responsible for retrieval of the agency nomination status - actually the complete nomination only without the agency nomination header identifier - as per specified individual agency nomination id. This operation shall be executed only by the nominee/agent.

# 1.8 Web Services – System Service

The System Service is responsible for all general purpose utility functions and functionality, which does not fall strictly into one of the other functional areas. Functionality provided includes the ability to get the current gas date and time from the VENCorp system, as well as information such as scheduling intervals and so on.

# **1.8.1 GetCurrentGasDate**

The getCurrentGasDate() method retrieves the current gas date from the VENCorp system.

# **1.9 Reason for Change**

The requested change will facilitate the implementation of the Wholesale Gas Market by providing Market Participants with ability to integrate their trading processes with the VENCorp's Gas Market Systems via the web services / automation interfaces described in this change request.

The submission and retrieval of information is via XML fragments constructed in line with rules for specific to the wholesale gas market transactions as would be defined in aseXML. The submissions are supported by web services' document style and literal use.

This change request also ensures that the consistency is maintained in the implementation of information exchange systems for Market Participants with the use of XML in the FRC area.

#### 2.3 Schema change description

The impact of changes required by this document is fairly minimal:

- An update to the top level schema to import additional wholesale schemas.
- Update of the Events schema to add an identifier for the release "r20".
- Update of the top level schema version to r20.
- An introduction of the wholesale market schema component.
- An introduction of the wholesale gas market schema component.
- Introduction of eight new Transactions
- Use of default versioning for transaction and type defined

The impact of this change request is reduced by the fact that only limited number of the existing types is used by the gas wholesale market schema: NMI and Period. Also, none of the transactions being defined within this change request are currently anticipated to be part of FRC B2B exchange. It is noted that the Guidelines indicate the use of Manadatory versioning at the Transaction Level. It is believed that the use of Default versioning with the introduction of new transactions is appropriate and will provide the benefit of minimising the amount of change needed to be performed with updates to the schema.

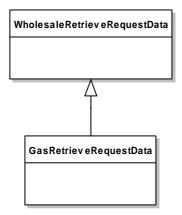

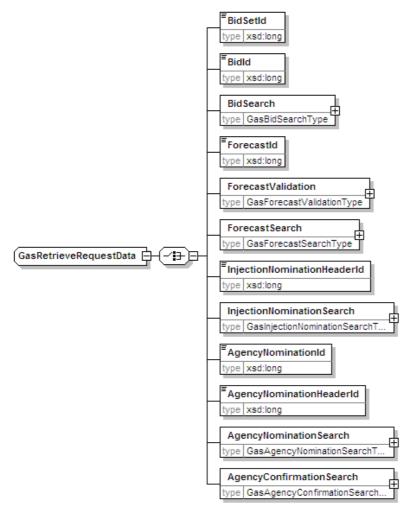

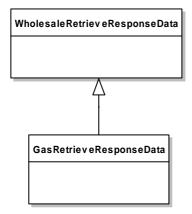
Below is a representation of the GasRetrieveRequestData complex element as required by gas wholesale market.



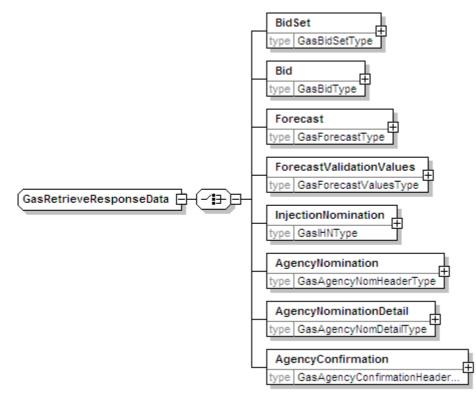

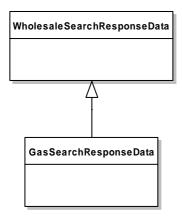


The following is a representation of the GasSearchRequestData element as required by the gas wholesale market.

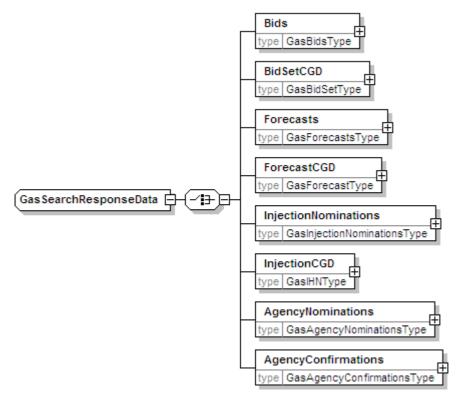

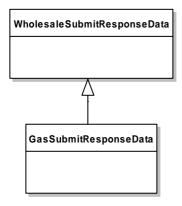


The following is a representation of the GasSubmitRequestData complex element as required by the wholesale gas market.

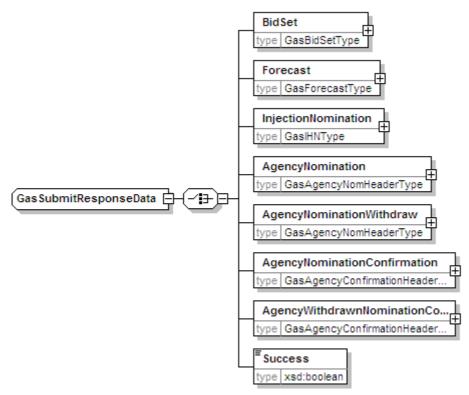
